### GENERAL TERMS AND CONDITIONS

SH Valencia Palace Hotel / October 1<sup>st</sup> to 3<sup>rd</sup>, Valencia – Spain

#### **Registration**

*The registration fee includes participation in the conference for three days (October 1<sup>st</sup> to 3<sup>rd</sup> 2025), book of abstracts (electronic format), delegate bag, luncheons, coffee breaks, conference dinner and welcome reception on first day. The registration fee must be paid online by credit cards or via bank transfer.*

Delegates who choose one of the categories of students, GEEA members, ASEFCA associates can benefit from a reduction by proving their status through a certificate of studies, student card or association membership enrolment.

*Please note that according to “Article 20.one. 14<sup>th</sup> of the Law 37/1992”, Spanish VAT law, the registration fees and all associated services are 21% VAT included.*

*Participants paying by credit card will receive written confirmation after finishing the registration process correctly.*

*Those delegates paying by bank transfer will automatically receive an email indicating the bank account and other payment details. In this payment category the delegate will assume all commission and charges incurred in the order. After receiving the bank account and the reference to pay, the registration fee must be paid within 14 days, as otherwise the preregistration could be cancelled.*

#### **Registration Fees / Cancellation Policy**

*Any modification or cancellation of your registration must be notified in writing to ADCOMM CENTURY S.L. (email: [info@adcommcentury.com](mailto:info@adcommcentury.com) ).*

- *Cancellations received in writing until August 1<sup>st</sup>, 2025, will have a 95% refund on the fee paid.*
- *Cancellations made between August 2<sup>nd</sup> and September 1<sup>st</sup>, 2025, will be refunded 50% of the fee.*
- ***No refunds will be accepted from September 2<sup>nd</sup>, 2025.** However, written substitutions will be accepted until October 15<sup>th</sup>, 2023 without incurring any additional charges. From September 2<sup>nd</sup>, 2025, substitutions are subject to a 25% administrative fee.*
- *All reimbursements will be made within 6 weeks after the Conference.*

*In case of cancellation by the Conference organization (due to force majeure.), 90% of the registration fee will be fully reimbursed, and the remaining 10% will be used to support the organization to mitigate the impact of the losses (venue, web page, suppliers, bank expenses).*

### ***Hotel SH Valencia Palace / Accommodation and booking conditions.***

***Reservations must be made directly with the hotel.*** There is an agreement with special room rates at SH Valencia Palace Hotel for all delegates (Conference venue). The agreed rates are 166.10 € (Double Room for Single Use) and 184.80 € (Double Room for Double Use). Both rates include buffet breakfast and 10% VAT.

*To benefit from these rates, you must use the promotional code provided through the "accommodation" tag of the Conference website.*

*The number of rooms is limited so we recommend to book as soon as possible.*

### ***Social Events: Welcome Reception and Banquet / Purchase and general conditions.***

*The welcome reception and the banquet are included in the registration fees for all categories. However, additional tickets for accompanying persons may be purchased online for €50.00 and €80.00 (21% VAT included).*

*Cancellations for the banquet are accepted until September 15<sup>th</sup>, 2025 upon written notification to the secretariat of the Conference (email: [info@adcommcentury.com](mailto:info@adcommcentury.com) ).*

*Substitutions will be accepted but in no case cancellations to attend the dinner, welcome reception or any other service of the Conference will be a reason to apply any discounts on the registration fee.*
