



GENERAL TERMS AND CONDITIONS OF ICASP7

June 10th to 13th, 2025, Madrid, Spain

The ICASP conference series is a prominent forum for researchers to present and discuss the latest advances and future directions in solidification science. After the great successes of the previous editions in Sweden (2005), Austria (2008), Germany (2011), UK (2014), Austria (2019), and France (2022), the event will be hosted for the first time in Spain. The main event will take place at the Retiro building of Madrid Technical University (Universidad Politécnica de Madrid – ETSI Caminos Canales y Puertos), within a 5 min walk from Atocha train station and the Retiro Park.

Registration

The Registration fee includes the attendance to scientific presentations (plenaries, keynotes and all parallel sessions), all coffee breaks, luncheons from Tuesday to Friday, poster session with standing cocktail, welcome reception, conference delegate bags, and poster printing (for authors presenting a poster contribution).

Registration can be only made online through "ADCOMM CENTURY" tool. Credit card (Visa and Master Card) and bank transfers are the methods of payment accepted. Early registration fee will be applied to all registrations until March 15th, 2025. From March 16th the regular registration fee will be applied.

Please note that, according to "Article 20.one. 14th of the Law 37/1992, Spanish VAT LAW, the registration fees and all associated services to them, are exempt from VAT.

Participants paying by credit card will receive written confirmation after the registration form is received by ADCOMM CENTURY S.L. Those paying by bank transfer will assume all commission and charges incurred. Confirmation will be sent indicating payment details. After receiving this confirmation, the registration fees must be paid within 14 days, otherwise the preregistration might be cancelled. After June 1st, 2025 online registration can only be paid by credit card. Please bring with you the confirmation statement at any case.

All changes or cancellations must be submitted to ADCOMM CENTURY, S.L. in writing (email: info@icasp2025.org) Cancellations received in writing until March 15th, 2025 are refundable, minus a 5% administrative fee. For cancellations received from March 16th, 2025 to April 30th, only 50% of the registration fee will be refunded. Cancellations received after May 1st 2025, are non-refundable. However, substitution of attendees will be accepted at any time with a written authorization letter from the original participant informing of the change of name.

In case of cancellation by the Conference organization (due to force majeure.), 90% of the registration fee will be reimbursed, and the remaining 10% will be used to support the organization to mitigate losses (venue, web page, bank expenses). All refunds will be made within 6 weeks after the official cancellation.





Banquet and Conference proceedings

Banquet: NONE of the fee categories includes the Banquet dinner on Thursday June 12th. Tickets for delegates and their accompanying persons can be purchased during the registration process (EUR 75.00 per person). On-site purchases can also be made if places are available.

Cancellations for banquet will be possible before June 1st, 2025. From this date onwards cancellations are non-refundable. However, any substitutions will be accepted at any time with a written authorization letter from the original participant informing of the change name.

All changes or cancellations must be submitted in writing (email: info@icasp2025.org) to ICASP7 Secretary Office.

Proceedings: Authors with an accepted talk or poster will be able to publish a full-length article in the conference proceedings. Accepted articles will be published as a special issue of IOP Conference series: Materials Science and Engineering. Article processing fees of EUR 85.00 per article must be purchased during the registration process.

Social Program for accompanying persons

The visits will depart from the Conference venue at 9.00am. Tours are limited to a minimum number of 10 participants on a first come, first served basis, and will be subject to cancellation & refund if an insufficient pre-registration is achieved prior to June 1st, 2025. The single rate for every excursion will be published in the Conference webpage

After receiving a written confirmation from ADCOMM CENTURY, the booking will be binding. The delegates will be able to buy extra tickets for them or their accompanying persons during the process of registration or to buy the accompanying package which includes the welcome reception, the standing cocktail and the banquet. In that case, the accompanying person will have to make a single registration through the registration website by selecting the accompanying people package fee.

Onsite payments will be also permitted upon request (with the increased on-site price). This however will not guarantee a place on the tours. Onsite registration & payments will depend on whether or not the sufficient number of participants has been reached at that time.

All changes or cancellations must be submitted in writing (email) to info@icasp2025.org Cancellations will be possible until June 1st, 2025 accordingly the established cancellation policy and the refunds will be made within 6 weeks after the conference. From June 1st, 2025 onwards cancellations are no refundable but substitution of attendees will be accepted at any time with a written notice from the original participant informing of the change of name.





Hotel Reservation / Cancellation Policy

Accommodation must be booked directly with the conference hotels. The hotels are conveniently located near the Congress venue which can be reached comfortably by walking. Rooms are based on availability at the time of booking.

Liability
